Website and Third Party Groups Terms and Conditions of Use

1. Introduction

These terms and conditions of use ('Terms') govern your use of our website ('the Website') and any groups, forums or pages that are created by us or in our names on third party sites ('Third Party Groups'). Please read through these terms in full before you use the Website and any Third Party Groups. By using the Website and/or any Third Party Groups you accept these Terms. 2. Amendments

We reserve the right to update and modify these Terms at any time. We may notify you of such changes by any reasonable means, including posting an announcement on the Website. It is your responsibility to review any modified Terms. Your continued use of the Website and/or Third Party Groups following changes to these Terms will constitute an acceptance.

3. Access

You are responsible for all access to the Website even if it access is by another person.

We reserve the right to restrict your access to the Website and/or a Third Party Group or part of them. Access to restricted areas of the Website and/or a Third Party Group may be subject to registration and other conditions. If we grant you permission to access a restricted area, we may withdraw that permission at any time (including where you breach any of these Terms).

 - solicit login information belonging to anyone else;
 - bully, intimate or harass any other user;

 - facilitate or encourage any breach of these Terms;

- 10.6. Nothing in these Terms shall exclude or limit liability for death or personal injury caused by negligence which cannot be excluded under English Law.

11. Law and Jurisdiction

These Terms are governed by English Law. Any dispute arising in connection with these Terms shall be subject to the exclusive jurisdiction of the Courts of England and Wales.
